Peabody Energy Corporation Updated CLO Exposure

Peabody Energy is a stressed credit. This report shows its exposure across CLO's as of the latest available monthly surveillance report on March 15, 2016. Holdings total \$353 million across all CLO's with almost 125 investments by 34 CLO managers in 123 CLO's. This is down from \$403 million held by 38 CLO managers on November 5, 2015. Five managers no longer own Peabody and two increased their holdings since the November report.
