# Peru's Central Bank Joins the Rate-Cutting Bandwagon

## Introduction

Monetary policy alone will be insufficient to temper an economic stall-out.

Peru's [central bank](#) met on Thursday to provide an emergency dose of monetary stimulus as the COVID-19 pandemic began to take a larger toll on [Peru's](#) economy. Bank directors delivered a 100-basis point rate cut, bringing the policy rate to 1.25%—a nine-year low. Policymakers also announced a series of extraordinary measures to bolster financial system liquidity, including the extension of repo facilities and new currency swap lines. While the announced steps will help to stabilize the financial system and prevent a freeze-over in credit markets, monetary policy alone will be insufficient to temper an economic stall-out.

Though the bank stopped short of proclaiming a recession in Peru, policymakers noted a rapid decline in economic activity in recent weeks. President Martin Vizcarra's emergency declaration—which forbids interprovincial as well as international travel and puts strict limitations on personal vehicles—will likely slow the economy further in coming weeks. The limit on driving and calls to practice social distancing have cut vehicle traffic in the Lima metropolitan area in half in the past seven days compared with the same seven-day period last year.

The Central Reserve Bank of Peru is the third major monetary authority in Latin America to announce emergency measures to stabilize a fast-emerging global recession. While the emergency rate cut is unlikely to do much to stabilize domestic demand—consumer spending had already slowed over the past year despite near-zero short-term rates—low and stable [inflation](#) clears the way for further action. While currency depreciation in [Chile, Mexico](#) and [Brazil](#) has pushed up consumer prices, putting inflation-fighting central banks in a bind, in Peru a less volatile sol creates room for additional rate cuts.

Despite increased stimulus, we expect Peru's economy to fall into recession in the first half of this year. This is under a baseline case in which global coronavirus infections stabilize by late April and business activity begins to recover. More severe scenarios are not difficult to imagine, and a prolonged hit to commodity prices could make for an even leaner year. Making things tougher is the expectation of only limited fiscal measures.
