NEW YORK, September 16 2016 - Moody's Analytics today launched Regulatory Reporter, a web-based tool that helps issuers of auto loan and auto lease securitizations comply with new asset-level reporting regulations in the United States.

"With the deadline for complying with the asset level information requirement of Reg AB II coming up in November this year, Regulatory Reporter is an essential tool for issuers of securitizations," Said Brad McNamee, Senior Director, Moody's Analytics. Regulatory Reporter generates a transaction report in the XML file format required by the Securities and Exchange Commission in support of the Asset Level Disclosure requirement for Auto Loans and Auto Lease, and automatically reconciles key fields between loan level and pool level data. In addition, the tool includes workflow capabilities for review, authorization and archiving to satisfy audit and compliance needs.

Regulatory Reporter can be used as a stand-alone tool or in conjunction with Moody's Analytics ABS System, the leading platform for issuers of structured finance transactions to model securitizations. ABS System is used by leading issuers globally, with over \$500 billion of outstanding securities currently monitored, managed and reported via the platform.
